A maximum residue limit (MRL) is the highest level of pesticide residue that is legally tolerated in or on food when pesticides are applied correctly in accordance with Good Agricultural Practice.

The USDA Foreign Agricultural Services departments developed a database containing maximum acceptable levels of pesticides and veterinary drugs in food and agricultural products in the United States, as well as 70 other countries, the European Union, and the Codex Alimentarius Commission.
